State Energy Legislation

Wyoming (Can we say what these bills are?)

- HB 116
- HB 40
- HB 228
- Senate File 7

Utah

- SB 275 soft cap of \$5 million Public Services Commissioner has the ability to adjust/go higher if necessary
 - Public Lands Forest Service extorting people working on federal lands/water rights; grazing permit – must transfer water rights to USFS
- HJR 14 Joint Resolution on Water Rights Colorado experiencing similar issues with ski areas
- HB 66 Water Rights Amendments
- Law enforcement BLM, USFS act law enforcement authority
 - HB 155 modifies code
 - RS 2477 88 miles prevailed in federal district courts
- Joint Resolution on State and Politics Subdivisions
 - o HJR 15
 - HB 164 passed jurisdictional authority of municipal authority
 - o HB 131 Federalism Defense Act will have a funded federalism committee

Alaska

- Legislature had three goals for the session and the first two dealt with energy
 - Get more oil through the Trans-Alaska pipeline
 - SB 21 changes the tax structure, led to increased activity, Chevron and Conoco Philips; tax structure stimulates economic development; citizens referendum to repeal the law
 - HB 4 moved \$300 million for in state pipeline; allow trucking from North Slope to Fairbanks – 40 trucks per day – 20 North and 20 South on gravel road to a gas storage facility in Fairbanks
 - o Permits
 - SB 27 take over 404 primacy, regulation of clean water
 - HB 129 permitting for oil and gas
 - Arctic Council Alaska (US is one of 8 participating countries); Sweden had the Chairmanship, now Canada's turn, US in two years. Passed legislation and funding –Artic Alaska Policy Commission
 - Injunction tax boning for NGO's in case of frivolous lawsuit
 - National Ocean Policy Resolution Administration grab on zoning around the US; Alaska would be our own zone, National Ocean Policy affects inland tributaries – basically every state could be impacted
 - Legacy Well issue Federal government clean up their wells

ENERGYPRODUCINGSTATESCOALITION

- Reclamation of old sites Administration takes a 50/50 split between state and government – take away from the states – coal sites
- Encourage ANWR Government in DC \$30 \$100 million; area 102 seismic, package of realistic path

Texas

- Big issue sunset review of agencies are adequately funded and staffed
 - Texas Railroad Commission appropriately named? And appropriate jurisdiction legislative deed
- Special Session called
- Roads funding wear/tear of roads, changes in truck traffic, CEA Trucking Safety Task Force
- Eminent Domain pipeline right of way
- Primacy EPA took over air permitting, green house gas emissions

Louisiana

• Taxes -\$500 million budget hole

o Governor's proposal died

Mississippi

- Nine pieces of energy related legislation
 - Production energy liquids play
 - Encourage more production provide severance tax holiday from 6% to 1.3% for 30 months
 - Lot of production
 - CO2 pipeline network
 - Use exempted state sales tax on energy used in manufacturing

Industry Update

ExxonMobil

- South Alabama:
 - o 25th anniversary of production in state waters Mobile Bay
 - o \$3 billion investment in offshore production
 - Alabama Trust Fund \$2 billion in last ten years in state royalties from producers such as EM; interest from ATF goes into the state general fund, Partnership for Progress
 - Operate in environmentally sensitive areas tourism is important to the state
 - Marine Well Containment Company hopefully will never need to be used; was recently successfully tested in Gulf during a full scale drill
- Access issue important synergies
 - VA, NC, SC promoting opening up coast to offshore development, added in Five Year Plan
 - States are the incubators for the ideas place where things are happening with respect to access and development. Example of where states can urge federal action: US Sens. Murkowski/Landrieu "FAIR Act" – promote responsible development of resources
 - Natural gas development the shale revolution has been responsible for \$60 billion in announced petrochemical capital investment projects in Louisiana
 - Long-term jobs for our kids and grandkids

ENERGYPRODUCINGSTATESCOALITION

- Governors in OCS cognizant of the symbolic importance of resolutions frame it as a larger access issue, encourage as much as you can
- o Nova Scotia lease sale offshore
- Local ordinances focused on anti-development & ballot initiatives eNGO's strategy per hydraulic fracturing
 - Governors have some authority per offshore development– Coastal Zone Plan
- Per question on Ocean Spatial Planning are other southern states going into that process?
 - OCS does not appear much appetite in the Gulf states

Shell

- States do it right
- Level of frustration on what's going on today
- Groups like this, EPSC, are important in finding common grounds, sharing ideas and themes important to move the ball forward
- Hydraulic Fracturing very important
- Water and Air issues
- Endangered Species Act
- Local bans how do you manage and go forward with it
 - Things that were not issues yesterday are today based upon opposition groups
 - o Oil and gas win on science what's working and what isn't
 - Boulder, CO public meeting/town hall tactics have changed
 - o Industry wants to have a voice
 - Our issues are your issues
- Q & As
 - Alaska offshore opposition instills fear communities realize jobs play a larger role
 - Had issues moving forward certain level of frustration why can't we move forward?
 - Do it right for the environment and reap the rewards of economic development
 - Microcosm of what federal issues are and what the process is
 - 27 different permits from 6-7 agencies, not much coordination amongst federal government agencies
 - Industry wins on science, opposition wins on emotion, as legislators, don't have the money for media campaigns to counteropposition. How do states reach them?
 - I think having public forums is important can't do this too much, look towards organizations like CEA, show Haynesville and have a discussion following.
 Hopefully, see more public dialogues and discussions moving forward "fear sells"
 - ExxonMobil Shell's "Rational Middle" link to YouTube, talks about the hard issues that are out there, help understand where the facts are
 - o How many assets that are federal mineral leases
 - In Marcellus, Mississippi Shale, Permian, Eagle Ford, Northern Louisiana
 - Exposure in federal lands is somewhat limited
 - Do you avoid federal leases for any particular reason?
 - Don't avoid them
 - ExxonMobil also have XTO so we have a presence in Wyoming, California, Alabama

• Largest natural gas producer in the country (XTO)

• There have been public meetings in Alabama, Texas where only 3 or 4 individuals from industry testify, with many more from opposition groups. Seldom see reps from industry, we'd encourage employees to be involved in the process

Mississippi Energy Institute

- Organization was spun out of state chamber let us be a resource research
- New Governor made energy major plan we helped write the energy plan
- Happy to engage in the media, we don't shy away from a good fight
- Energy isn't supposed to be a partisan issue, particularly in energy states
- Good things are happening at the state level GDP issue that will prove itself out
- Get DC to be a little more coherent by showing the example in the states

Federal issues

Endangered Species Act

- Root of the problem is settlement agreements
- BLM resource management plans moving requirements outside core areas

Ocean Policy

- Zoning plan for offshore not just limited to federal waters
- Executive orders states have to have regional planning bodies
- Natural ally in the fishing industry
- Inland states tie water resources to this similar to wilderness designation
- Every sector of the economy is impacted
- Alaska Department of Law person working on it
- OCS Governors should come out on this issue
- Nationaloceanpolicy.com

OCS Access

- Meeting in Houston 6 Governor's and 2 senior staff
- Need for more access, modify five year plan
- Interest in Mid/South Atlantic 3D Seismic to be shot
- FAIR ACT revenue sharing, ways to improve process for offshore permitting and access
- States are lining up in support
- ExxonMobil move to re-open 2012-2017 plan, some are just focused on 2017-2022 plan make sure focus is on today

Seismic

- DOI authority to shoot seismic, preparing for EIS
- Organizations lining up to oppose seismic claiming it is harmful to marine life
- ExxonMobil stop seismic, stop E&P activity
- Alaska Apache shooting seismic has been stopped by BLM

• Key energy components – IDC particularly damaging to oil and gas exploration, typically 25% of exploration budget

Revenue sharing

- Critical that states receive revenue from royalties, rentals and bonus bids
- Only fair through Mineral Leasing Act issue that has legs (OCS sharing)
- Do inland Governor's get same connection as Gulf Governors?

Western Caucus

- What are the issues stopping energy production?
 - o Access
 - o NEPA
 - o ESA
 - o Ocean Policy/Permitting
 - Federal lands, state trust land land exchange
 - Federal regulations vs. Congressional action
- Action plan of 2 to 3 things to get done
- 20th year in the House- started by former Rep. Hansen (UT) there wasn't a coalition dealing with Western state specific issues
- Advance and push legislation
- Serve as advocates for West what it means to be a public lands state "West exists as a playground for the east."
- Website WCU
- Social media
- "Bull Report"
- State Mineral Protection Act
 - 48-52 split in revenues (2% processing fee)
 - \$110 million under sequestration
 - 2 ways to try and fix it
 - Legislation response to repeated pattern when in a budget crisis rob Peter to pay Paul
 - Mistake allowed state revenues to leave the border filter back to states
 - Make operators cut two checks split equally 50-50 between state where development occurred and the federal government
 - o Benefits:
 - Gets state their royalties earlier
 - Make it a lot harder to do what the Federal government is doing - taking case
 - Ends 2% transaction fee charged to states
 - Opt-in process
 - Letter legal case to why DOI has misinterpreted sequestration
 - 1985 sequestration budget gimmick withheld payment for only the current fiscal year, sequestered money paid back at the beginning of the next fiscal year

ENERGYPRODUCINGSTATESCOALITION

- Interpret law the way they did in 1986
- Legal action next year if not paid back
- State Attorneys General of most affected states coalition send a similar letter
- Collaboration
 - 2 suggestions
 - Establish a more formal connection between EPSC and staff of members of Western Caucus
 - Letter to staffer/member requesting participation
 - Policy Ocean Policy could be one of the issues to focus on in the future; Lummis bill could be an immediate action
 - EPSC Federal Advisory Caucus
 - The way we talk about it Messaging
 - Rapid response team put out things to counter inaccurate statements about particular issues, example hydraulic fracturing
 - Community involvement
 - How do we talk about it and how do we message it?
 - Make it resonate with families "need it for family's future/security"
 - o Suggest reviewing Western Energy Alliance polling
